About the Commission on Crime and Gambling Related Harms

The Commission on Crime and Gambling Related Harms was launched by the Howard League for Penal Reform in 2019 and is scheduled to run until the end of 2022. The Chair of the Commission is Lord Peter Goldsmith KC. He leads a team of 12 Commissioners, comprising of academics and professionals with expertise in the criminal justice system and public health, as well as experts with knowledge of the gambling industry and with lived experience of addiction. The Commission seeks to answer three questions:

- What are the links between crime and gambling harms?
- What impact do these links have on communities and society?
- What should be done?



Conference rooms

Registration is located in the Sloane Robinson Foyer.

The conference is taking place in the Sloane Robinson and Arco buildings, centred around the Newman Quad. Plenary sessions will take place in the O'Reilly Theatre, on the ground floor of the Sloane Robinson building. Participatory plenary sessions will take place in the O'Reilly Theatre, the Douglas Price Room, the Jean Robinson Room, and seminar room 1. Parallel sessions will take place in the Sloane Robinson building, seminar rooms 1–6, located on the second floor; the Douglas Price room located on the first floor; the O'Reilly Theatre; and the Jean Robinson room located in the Arco building.

The conference office is located in room 1514, on the Liddon Quad.

Refreshments

Tea and coffee will be served in the Arco building (the Roy Griffiths/Stafford Crane Rooms). Lunch will be served in the Dining Hall. The conference dinner will be held in the Dining Hall at 7.30pm on Tuesday 13 September.

The bar, located in the Hayward Quad, will open until 11:30pm (with last orders at 11pm) and delegates are welcome to use it.

Accessibility

Keble's main site is based around five Quads with buildings that vary in age and style, making some areas more accessible than others. However, many of its staircases have contrasting edges, automatic lighting and handrails, and it's possible to access the iconic dining hall, the seminar rooms, lecture theatre and accessible bedrooms without using stairs.

The site provides ample space for guests to move around easily, free from trip hazards or obstructions. Many rooms feature powered doors and facilities are signposted throughout the venue. There are a number of lifts to transport guests to rooms, including the Seminar Rooms in the Sloane Robinson building.

The O'Reilly Theatre provides seating for up to 250 delegates has level access, a lift for balcony wheelchair seating and an accessible toilet.

Keble's magnificent dining hall boasts a huge open space with plenty of room to manoeuvre a wheelchair. Located on the first floor, it can be accessed via stairs or lift which transports guests directly into the hall. The Chapel can also be accessed via a temporary ramp with ample space inside to accommodate wheelchair users. The College's grade 2 listed bar has ramped access

The College includes nine accessible toilets in several locations including the bar, Sloane Robinson Building and Arco Building. Keble has a total of six lifts across its sites, providing step free access for guests. Its range of platform and passenger lifts include rails and buttons at an accessible height with many featuring audio information and backlit buttons with braille.
